Reports:

H&I - We have been taking virtual speaker meetings, three days a week, out to ARCA for the entire duration of the restrictions. In the past month, maybe five weeks, we have taken discussion meetings on thursdays. Those were slow to no discussion from clients, so we went to a virtual ask it basket. Clients

write a question they would like the panel to discuss or answer for them, during the meeting, and we simply offer each question to the group of AA's and create discussion from there. I was lucky enough to be invited to a panel discussion with about 125 other trusted servants from around the country, to talk about how to carry a message with depth and weight, virtually, into hospitals and treatment centers. The last thing I mentioned was that I have a contact name to put a call in to see if we can do the same, or similar things at OV.

Accessibilities - Absent

Answering Service - 03/30-04/26 there were 84 calls, 161 min talk time, 3 were 12 step calls, 4 were missed calls, all others were handled by recording or answering service. The recording has been changed and now directs you to the website, RideShare, and zoom meetings. It was noted that last month it was more expensive and this month it has gone back down, and since we pay for a specific amount of minutes if an answerer is on a long call and feels comfortable it would be helpful to have them get the caller's number and call them back.

Kim T. is interested in fulfilling the empty answering service chair position. Kim M. is also interested in the position. Both candidates expressed interest in either chair or co-chair position.
