REPORTS:

Treasurer - Total income, \$1933.15. Expenses 1285.20. Net income 646.90. Accepted unanimously.

H&I - "Steady as she goes". Been in contact with Accessibilities and answering services build a helping hand for those fresh out of treatment centers, they are working on an information packet. ARCA has been going well: 2 speakers, Thursday ask it basket, Friday literature study per week. Still working on Old Vineyard, but they have been watching how we bring the message to Arca.

Accessibilities - A brief summary including some of what H&I touched on. Building a packet with what right information to put in said newcomer packet. Has reached out to the old Drivers list to see how many people are still available to take people to meetings. Possibly partnering them with answering service and doing away with the web hosting for the ride share app to save the intergroup a little money.

Answering service - \$116.57. Have been building new participants to answer. We do not currently have a standing co-chair for this position and they need help. Two calls were

patched through to AAs. Many other calls did not get patched, but instead gave them meeting information/zoom numbers/etc. When the service is very busy they are placing some people on hold for an average of up to six minutes and some people are hanging up. Is that what we want?

A discussion was had, some points that were made follow:

- Historically, yes we went ahead and gave them a meeting list to save us some money with patching, but we also have had to nudge them not to give 12-step advice that they are not qualified. We could just tell them to give them the website or patch them through, no “in-between”.
- Possible to form a small group to look at the answering service, what they’re doing, and how we can get more AAs involved.
