Subcommittees:

- Treasurer's Report: The January finances were discussed. First of all, "thank you" to each of the home groups for their continued support of Intergroup. The IG had more expenses than income in January, but we remain above the prudent reserve
- H & I / Treatment: The committee is working on developing a contract at Baptist Hospital. They are also checking on the needs of the Old Vineyard facility and Hope Valley.
